REGISTRATION

WEIGH-IN AREAS

All competitors must be present Friday, January 20 at 1:00 p.m. and on Saturday, January 21 at 7:00 a.m. Contestants must weigh-in Friday and Saturday in order to compete. Female weigh masters will conduct the weigh-in and check conformance to appearance as required by the National Federation 2005-2006 Wrestling Rule Book. All coaches must bring the Alpha Master List indicating that the participating wrestlers have completed the CIF Weight Management Assessment as required by CIF Bylaw 3104.

WEIGHT CLASSES

The following weight classes will be in effect for the CIF Girls Regional Wrestling Tournaments. Note: the 2-pound growth allowance will be used in accordance with the National Federation Wrestling Rules. In addition, there will be a 1 pound allowance for Saturday morning weighins; Rule 4.5.5.

ENTRIES PER WEIGHT CLASS

Initially, entries per weight class shall be capped at 32. Should more than 32 wrestlers in a given weight class register for either regional tournament, tournament management will have the discretion to expand selected weight class brackets beyond 32 entries if tournament schedule and facilities can accommodate such expansion. In no case shall total participating wrestlers in either tournament exceed 448. If necessary, criteria shall be implemented which provides that priority shall be given to including those wrestlers representing the greatest number of CIF sections, leagues and schools.

RULES

The National Federation 2005-2006 Wrestling Rule Book will be the official rules for the tournament, superseded by the State CIF Rules (including CIF Bylaws 3103 & 3104 pertaining to weigh-ins and CIF Weight Management Assessment.

DRESSING QUARTERS & SHOWERS

Locker rooms with showers will be provided for the athletes

BRACKET INFORMATION

WEIGHT-CLASS PAIRINGS

Pairings for the weight classes will be done by the CIF.

SPECTATORS

CIF events are conducted under the strictest code of good sportsmanship. Fans are encouraged to support their own school's representative, but are requested to refrain from booing the opponents or the officials.

STATE CIF PASSES HONORED
