- No admission fee will be charged at this 1st-Round game;
- No facility cost will be charged to CCS for use of this home or alternate site;
- On-field batting practice is NOT allowed at any CCS Play-off site, including 1st-Round sites;
- 1st-Round game times will be 4:00pm, unless circumstances require otherwise. Time changes must be requested in a timely fashion by an Administrator or Athletic Director and require authorization by the CCS Commissioner or designee;
- Host teams are responsible for calling in game scores to the CCS office immediately following the contest (408-224-2994 x20).
