SUBJECT: CCS NORTHERN CONFERENCE REALIGNMENT COMMENCING IN
THE 2008-2009 SCHOOL YEAR

The Northern Conference of the CCS met on March 26, 2007 at San Mateo UHSD's SMART Center. There were 37 ratified representatives present at the meeting which constitutes a quorum (46 schools-31 needed for quorum). The Northern Conference Realignment Sub Committee forwarded two proposals; two more proposals were circulated by member schools. There was no motion for any amendments or new proposals made from the floor. Therefore, ballots were distributed with the four proposals with direction for the school representatives to vote for one.

The first ballots were tabulated by the CCS Commissioner and myself and reported verbally to those present. The results are as follows.

- 1. PROPOSAL #1 from Realignment Committee** **17**
 - CPSAL into PSAL;
St. Lawrence only remaining school in PSAL from original PSAL schools
Fremont Chr, Valley Chr Dublin and Redwood Chris leave to NCS
 - Most PSAL into WBAL;
include SHP and Menlo School in WBAL
- 2. PROPOSAL #2 from Realignment Committee** **13**
 - CPSAL into PSAL;
St. Lawrence only remaining school in PSAL from original PSAL schools
Fremont Chr, Valley Chr Dublin and Redwood Chris leave to NCS
 - Most PSAL into WBAL;
include SHP in WBAL; Leave Menlo in PAL
- 3. PROPOSAL #3-from Sacred Heart Prep** **5**
 - CPSAL into PSAL;
St. Lawrence only remaining school in PSAL from original PSAL schools
Fremont Chr, Valley Chr Dublin and Redwood Chris leave to NCS
 - Most PSAL into WBAL;
 - Leave Menlo in the PAL and place SHP in the PAL
- 4. PROPOSAL #4 from Kehillah Jewish** **1**
 - Dissolve, PSAL; CPSAL stays the same
St. Lawrence only remaining school in PSAL from original PSAL schools
Fremont Chr, Valley Chr Dublin and Redwood Chris leave to NCS
 - Most PSAL including St. Lawrence into WBAL
 - Leave Menlo in the PAL and place SHP in the PAL

The consensus of all present was to drop off Proposals #3 and #4 and vote between Proposal #1 and #2.

Ballot #2 was distributed and school representatives were directed to vote for either Proposal #1 or Proposal #2

The second round ballots were tabulated by the CCS Commissioner and myself and reported verbally to those present. The results are as follows.

1. PROPOSAL #1 from Realignment Committee **25**

➤ CPSAL into PSAL;

St. Lawrence only remaining school in PSAL from original PSAL schools
Fremont Chr, Valley Chr Dublin and Redwood Chris leave to NCS

➤ Most PSAL into WBAL;

include SHP and Menlo School in WBAL

5. PROPOSAL #2 from Realignment Committee **12**

➤ CPSAL into PSAL;

St. Lawrence only remaining school in PSAL from original PSAL schools
Fremont Chr, Valley Chr Dublin and Redwood Chris leave to NCS

➤ Most PSAL into WBAL;

include SHP in WBAL; Leave Menlo in PAL

I attest that all representatives that day were checked in against a list of ratified representatives; that we had a written proxy for anyone not on the ratified list of approved voters for each school; and that a quorum was present allowing us to conduct business; and that all CCS bylaws were followed in this process.
